



Dear Neighbor,

I'm pleased to report that the bill I amended to include Blair's Law designed to deter potentially deadly celebratory gunfire passed the Missouri House of Representatives on April 19 by a vote of 109 to 36, with 7 legislators voting present.

The amended bill (House Committee Substitute for House Bill 944) is now awaiting a hearing by the Senate General Laws Committee. The original bill was introduced to allow discharge of a firearm from a stationary motor vehicle on private property in rural areas to protect livestock from predators.

Other amendments were added to the bill that I didn't support, but with the addition of Blair's Law I strongly believe the amended version will do more to improve public safety than to harm it.

Blair's Law will make celebratory gunfire and any other discharge of firearms with criminal negligence within or into city limits a serious state offense, with the first violation being a Class A misdemeanor, the second a Class E felony and subsequent violations a Class D felony.

Currently celebratory gunfire in Kansas City is just a city ordinance violation unless there are specified aggravating circumstances.

This legislation is named after 11-year-old Blair Shanahan Lane who died after being struck by celebratory gunfire here on July 4, 2011. During the

decade since then, her mother, Michele Shanahan DeMoss, has devoted countless hours to try to reduce celebratory gunfire and warn others of its dangers.

For the week beginning Tuesday, April 27, the site is giving first doses of Pfizer vaccine and second doses of Moderna vaccine. For the week beginning Tuesday, May 4, the site is giving first and second doses of Pfizer vaccine and second doses of Moderna vaccine. After that the site only will administer Pfizer vaccine which is available for persons 16 and over.

SENATE PANEL DEADLOCKS ON MEDICAID

The Senate Appropriations Committee on April 21 deadlocked 7-7 on restoring funding for Medicaid expansion in the 2022 fiscal year state operating budget.

The funding fight now moves to the full Senate, with a lawsuit almost certain if the spending authority ultimately is omitted from the final appropriations bills.

As of July 1, every Missourian whose income is at or below 138 percent of the federal poverty level will be eligible for the state's Medicaid program under a constitutional amendment Missouri voters ratified last year. Without full funding to cover the additional recipients, however, the program could exhaust its spending authority well before the end of the fiscal year. An estimated 275,000 additional uninsured Missourians will be eligible for the program.

After the vast majority of House Republicans stripped the funding for Medicaid expansion from the budget, many supporters, including the state's major medical and business organizations, had anticipated the Senate would prove more reasonable and not go along with defying a voter-approved constitutional mandate. However, Senate Appropriations Committee Chairman Dan Hegeman, R-Cosby, joined six other Republican committee members in voting against expansion funding. Three Republicans joined the committee's four Democrats in support.

Under the federal Affordable Care Act, the federal government will pay 90 percent of the cost of expansion, or about \$1.4 billion for FY 2022. In addition, implementing expansion will secure an additional \$1.5 billion for Missouri under the most recently passed federal COVID-19 relief bill. Such a large influx of spending would create tens of thousands of jobs and provide a tremendous economic boost to the state.

Gov. Mike Parson has moved to implement expansion as required by the state constitution and requested that it be fully funded for the upcoming fiscal year, which begins July 1. Lawmakers face a May 7 constitutional deadline for completing work on the budget.

STATE HEALTH DIRECTOR RESIGNS

After four years leading the Missouri Department of Health & Senior Services, Dr. Randall Williams resigned as the agency's director on April 14 without explanation. Given that Williams had weathered several controversies during his tenure, his sudden departure amid no information on its cause came as a surprise.

The news became public in a press release from Gov. Mike Parson announcing he was naming Robert Knodell, his deputy chief of staff, as acting health department director. Williams has made no public statement on his departure.

Former governor Eric Greitens appointed Williams, who had previously served as health department director in North Carolina, to the Missouri post in 2017. Williams stayed on after Greitens resigned in 2018, and Parson repeatedly had expressed support for Williams.

Williams took fire for the state's response to the COVID-19 pandemic and the slow rollout of mass vaccination sites, particularly in the state's major urban areas.

Just two days before his resignation, Williams was a speaker at my request for the virtual monthly meeting of the South Kansas City Alliance,

and provided very helpful information about vaccine availability in the area.

HOUSE EXPELS MEMBER FOR ALLEGED ABUSE

Without dissent, the House of Representatives on April 21 voted to expel state Rep. Rick Roeber, R-Lee's Summit, after the House Ethics Committee issued a report outlining allegations that during the 1990s he had abused his four children, who are now adults. The expulsion, the first in 156 years, came on a vote of 153-0, with one Republican lawmaker voting present.

The committee released its report two days earlier and found credible evidence Roeber had sexually abused two of his children and physically abused all four. Although some of the incidents of abuse were reported to state and local authorities at the time, Roeber was never criminally charged. The committee found Roeber's testimony to be combative and not credible.

After first telling the committee he intended to fight any attempted punishment, Roeber submitted a letter of resignation on April 13 shortly after news broke that House leaders had contacted prosecutors and police in Jackson County expressing concerns about Roeber's continued contacts with a minor child. Two days later, the House unanimously voted to temporarily reject Roeber's resignation pending completion of the ethics report.

The only other legislative expulsion in Missouri history took place on Jan. 4, 1865, when the House voted to oust state Rep. John Sampson of Callaway County for disloyalty to the Union because he had attended a secessionist rally in April 1861.

A Senate expulsion trial against state Sen. Joseph Falzone of St. Louis for allegedly soliciting a \$1,500 bribe commenced on Oct. 29, 1945, but his subsequent resignation on Nov. 1 terminated the proceedings before they concluded.

HOUSE KILLS BILL OVER StL E-TAX PROVISION

The House of Representatives on April 19 voted 70-83 to reject legislation that originally sought to authorize a handful of outstate cities to adopt a special public safety sales tax after a provision was added to exempt many telecommuters from paying St. Louis City's earnings tax.

The original intent of House Bill 394 was to give certain cities the power to ask their voters to approve a half-cent sales tax for their police and fire departments. However, an amendment was added during House debate that would have prohibited St. Louis City from imposing its 1 percent earnings tax on people who live or work in the city on non-city residents who telecommute for city-based jobs.

Without that provision, the otherwise non-controversial bill likely would have passed easily. Instead, Democrats opposed to tinkering with St. Louis' earnings tax and Republicans who didn't like the sales tax combined to provide enough votes to defeat the measure. I voted no.

HOUSE REJECTS LIMITING COMMUNICATIONS

The House of Representatives on April 19 defeated legislation that sought to limit how local governments can communicate with voters regarding ballot measures. The bill fell on a vote of 72-82-1. I voted no.

Under existing law, local governments already are prohibited from contributing public funds to campaigns supporting or opposing ballot measures. However, they are allowed to provide factual information to voters regarding the impact of ballot measures, and local officials are free to issue news releases discussing their positions on them.

House Bill 512 sought to prohibit local governments from distributing any printed materials related to ballot measures. Supporters said new restrictions are needed because local officials sometimes skirt existing

rules. Opponents said the bill's restrictions went too far and would prevent local officials from providing factual information on important public policy issues.



I spoke against passage of House Bill 952 that would prohibit public school districts and charter schools from using material in any courses from the 1619 Project of the New York Times Magazine that

chronicles the profound effect slavery has had on our country since the first slave ship arrived in 1619 when the bill was heard in the House General Laws Committee on April 19. I feel students need to learn all aspects of our great nation's history, both the good and the bad, and that the legislature has no right to censure reputable sources of information just because they include uncomfortable truths or controversial assertions.

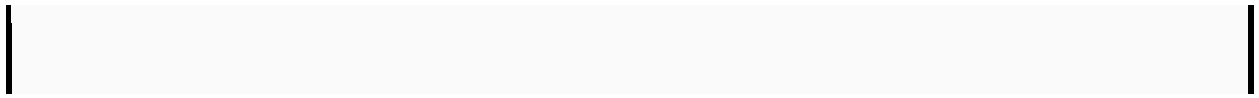

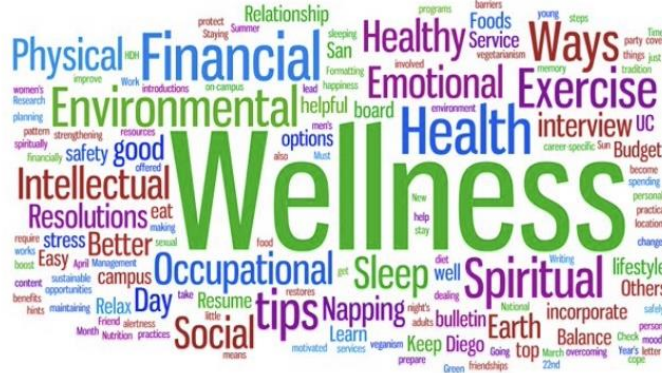

Persons should go to the entrance to the Center Administrative Office and drive through the bus parking lot to the warehouse where volunteers will load the food. Persons should take the Troost Ave exit. The event is sponsored by the Center Education Foundation in partnership with the Center School District.

Evangel Church, 1414 E. 103rd St., from 7 to 8:30 a.m. the second Saturday of the month. Persons may remain in their vehicles, and food will be brought to them.

United Believers Community Church, 5600 E. 112th Terr., with vehicles lining up at 8:30 a.m. and contactless food distribution running from 9 to 11 a.m. the third Wednesday of the month.

Ruskin High School, 7000 E. 111th St., from 4 to 5:30 p.m. the third Thursday of the month. Vehicles should line up on Ruskin Way on the east side of the school, and food will be loaded in the vehicles when they reach the school by staff and student volunteers. This event is sponsored by the school and Community Assistance Council.

Colonial Presbyterian Church, 9500 Wornall Rd., with registration beginning at 8 a.m. and food distribution running from about 8:30 to 10 a.m. on the third Saturday of the month. Families are asked to bring two cardboard boxes for volunteers to put the food in.

Center High School, 8715 Holmes Rd., from 11 a.m. to 1 p.m. as long as food is left on the third Saturday of the month. The event is sponsored by Three Trails Community church in partnership with the Center School District.
