Please scroll down to see proposed enhancements to law enforcement training in Missouri planned to take effect in 2022 designed to improve interactions between law enforcement officers and members of the communities they serve.

In breaking news about upcoming local events, it was recently announced that the **6<sup>th</sup> Council District Cleanup from 8 to noon tomorrow, Saturday, Oct. 10, will offer free document shredding at both drop off sites** – the east parking lot of Ruskin High School, 7000 E. 111<sup>th</sup> St., and the parking lot of South-Broadland Presbyterian Church, 7850 Holmes Rd. Originally, shredding service was only going to be available at the church.

And scroll down for more information about **a drive-through food**

**distribution for needy families starting at noon Saturday, Oct. 10, at United Believers Community Church, 5600 E. 112<sup>th</sup> Terrace.**

Also, please remember that two satellite locations in south Kansas City will be open from Oct. 13-31 to allow in-person absentee voting by KCMO voters who live in the Jackson County portion of the city. The sites are **United Believers Community Church, 5600 E. 112<sup>th</sup> Terrace, and Gregory Hills Church, 7020 James A. Reed Road.** They will be open from 10 a.m. to 6 p.m. Monday-Thursday, 10 a.m. to 5 p.m. Friday and 10 a.m. to 2 p.m. Saturday. Voters should bring identification.

Voters may vote absentee because of:

- Absence on election day from the KC Election Board's jurisdiction
- Religious belief or practice
- Employment by an election authority at a location other than their polling place
- Certified participation in the state's SAFE AT HOME address confidentiality program

However, persons voting absentee for any of these reasons have to get their ballot envelopes notarized if they vote absentee by mail.

Voters may vote absentee by mail without getting their ballot envelopes notarized if they are in an at-risk category for contracting COVID-19 because they meet at least one of the following criteria:

- Are 65 years of age or older
- Live in a licensed long-term care facility
- Have serious heart conditions
- Have chronic lung disease or moderate to severe asthma
- Are immunocompromised
- Have diabetes
- Have liver disease
- Have chronic kidney disease and are undergoing dialysis

KCMO voters also may vote absentee by mail without getting their ballot envelopes notarized if they need to vote absentee because of incapacity or confinement due to illness or physical disability, or because of caring

for a person who is incapacitated or confined due to illness or disability.

## **Mark A. Sharp Weekly Capitol Report** **Friday, October 9th, 2020**

### **DE-ESCALATION & IMPLICIT BIAS TRAINING MOVES FORWARD**

The Peace Officer Standards and Training (POST) Commission which oversees training for Missouri law enforcement officers unanimously voted on Oct. 5 to take the first step to require all officers to undergo annual training in de-escalation techniques and implicit bias recognition.

.When implemented, beginning in 2022 Missouri police officers and deputy sheriffs will take a one-hour course on each subject as part of their required 24 hours of annual continuing education training which already requires one hour of training concerning racial profiling.

“We believe these training changes, which were unanimously approved by the POST Commission, will lead to better interactions between officers and the public and can help strengthen relations with the communities we in law enforcement serve,” Platte County Sheriff Mark Owen, the Commission chairman, said in a news release.

De-escalation training for law enforcement officers was proposed by then KCMO Police Chief Darryl Forte in 2015. My father John Sharp, then chair of the KCMO City Council Public Safety Committee, recommended that such training be required at a POST Commission hearing that year in our city and it was included in officers' initial training. (As a state representative, he was a sponsor of legislation passed in 1978 to establish the first statewide training requirements in Missouri for law enforcement officers.)

Commission staff is currently finalizing the rules for this new training to submit to the Secretary of State's Administrative Rules Division and the Joint Committee on Administrative Rules of the General Assembly which will begin the public comment process required by state law before new state administrative rules can get final approval. After the public comment process is concluded, agencies must finalize proposed new rules including any changes made in response to such comments.

**Persons wishing to comment on these training enhancements should send their comments to the Commission, and I will provide details on how to do that in a future Capitol Report.**

In other action Oct. 5, the Commission appointed committees to work on two other proposals:

Developing a course of instruction for Missouri's licensed law enforcement training centers on the history of policing and minority community relations.

Exploring ways to require law enforcement agencies to check with the Commission on an applicant's past history as an officer before hiring experienced officers.

A tentative special meeting of the Commission is scheduled for December 15 to review the committees' work.

The Commission's actions were the result of requesting and receiving

over 2,000 responses from the public and law enforcement officers to a survey about law enforcement training and conducting three virtual listening sessions to allow the public to submit further comments by email.

House Minority Leader Crystal Quade also had written Gov. Mike Parson on June 8 asking him to direct the Commission to overhaul training requirements to de-emphasize the use of force.

In the same letter, Quade asked Parson to make the necessary appointments to bring the POST Commission to full strength. At the time, eight of the Commission's 11 seats were either vacant or held by members serving long-expired terms. "A commission this important to public safety in Missouri cannot be allowed to operate on autopilot," Quade wrote.

Parson made two appointments a week after Quade's request, but took no action on the other slots. Three Commission spots remain vacant while another four are held by persons with expired terms, including one whose term recently ended.

The Commission also gave preliminary approval Oct. 5 for Lincoln University in Jefferson City to establish a licensed law enforcement training center which would be the state's 20th. According to a news release, this would be the first such training center based at a historically Black college or university.

Both POST Commissioner Paul Williams, Springfield police chief, and Clay County Sheriff John Wheeler said this should help enhance minority recruitment which they said is currently difficult.

## **GOVERNOR RECOVERS FROM COVID-19, RESUMES SCHEDULE**

Gov. Mike Parson announced on Oct. 4 that both he and First Lady Teresa Parson had fully recovered from COVID-19, and he was

resuming a full schedule of public appearances and other official and campaign activities. The couple tested positive for the disease on Sep. 23 and went into isolation. The governor said he experienced no symptoms while the first lady had only minor symptoms.

After several days of requests, the governor also revealed in a news release that four members of his staff had tested positive for COVID-19.

Although the Parson administration was originally reluctant to say how many members of the governor's staff were infected, it has no qualms about releasing the same information about employees at other state agencies. According to data provided by the state Office of Administration, which Parson oversees, the St. Louis Post-Dispatch reported that a total of 1,842 state employees had tested positive since the pandemic started in March.

Of those employees, 1,259 had recovered, according to the paper. The Department of Corrections had the most reported employee cases by far with 646, while the Department of Mental Health was a distant second with 393. The Department of Public Safety was third with 211 cases.

## **STATE REVENUE COLLECTIONS LEVEL OFF DURING SEPTEMBER**

Net state general revenue collections leveled off during September as a massive infusion of cash caused by a three-month delay in this year's income tax filing deadline finally subsided. Net general revenue collections for September 2020 increased 3 percent compared to September 2019, going from \$917.3 million last year to \$944.5 million this year.

Net general revenue collections for July 2020 and August 2020 had increased 96.4 percent and 54.1 percent, respectively, compared to the same months in 2019 as Missourians finally paid income taxes that normally would have been due April 15. In response to the COVID-19 pandemic, the federal and state governments both postponed the filing

deadline until July 15.

While the move granted taxpayers a temporary reprieve during the pandemic's early stages, it caused state revenue collections for the final quarter of FY 2020 to crater and prompted Gov. Mike Parson to impose nearly \$435.38 million in unilateral budget cuts for that fiscal year.

Through the first quarter of FY 2021, net state general revenue collections increased 33.8 percent compared to the same period in 2019, going from \$2.31 billion last year to \$3.09 billion this year. Despite the influx of delayed revenue in FY 2021's early months, Missouri's financial outlook for the rest of the year is still a concern due to the pandemic's ongoing economic impact.

In addition to last year's spending reductions, Parson had imposed another \$448.85 million in pre-emptive cuts to the FY 2021 state budget. However, the governor on Oct. 7 restored nearly \$38.26 million in spending authority. Higher education funding accounted for \$26.53 million of the restoration, or nearly 70 percent.

After a long delay, Parson also on Oct. 7 finally allocated \$94.7 million in federal coronavirus relief funds. The bulk of that money, \$63.75 million, was directed to the Missouri Department of Elementary and Secondary Education.

## **GOVERNOR PICKS NEW STATE HIGHWAYS COMMISSION MEMBER**

Gov. Mike Parson on Oct. 1 appointed W. Dustin Boatwright of Scott City to the Missouri State Highways and Transportation Commission. The six-member commission is the governing authority for the Missouri Department of Transportation and determines how state and federal transportation revenue is spent in the state.

Boatwright is chief engineer and executive vice president of the Little River Drainage District. He can begin serving on the commission

immediately, but the Senate must confirm the appointment when it reconvenes in January. If confirmed, Boatwright will serve a term ending in March 2025.

Boatwright replaces Michael Pace of West Plains, whom Gov. Jay Nixon appointed to the post in 2015. Although Pace's term expired in March 2019, he continued to hold a seat on the commission until Parson picked a replacement.

Parson could at any time appoint a replacement for a second highway commissioner who also is serving on a term that ended in 2019. In addition, the terms of two more commissioners will expire in March.

### **STATE SUPREME COURT HEARS ABSENTEE VOTING CASE**

The Missouri Supreme Court heard arguments Oct. 6 in a case arguing that certain provisions of state law governing absentee and mail-in voting are confusing and unconstitutionally infringe on the right to vote. With the Nov. 3 elections looming, the court is expected to rule soon.

At issue is a new state law that expanded absentee voting and voting by mail. The law requires some voters to have their ballots notarized but not others. Whether notarization is required has created a good deal of confusion, especially as more Missourians choose remote-voting options to avoid crowded polling places on election day to reduce their risk of contracting COVID-19.

The plaintiffs, who lost at the trial level, are asking the state high court to waive the notarization requirements and order local elections officials to count all otherwise valid absentee and mail-in ballots that haven't been notarized. The case is *Missouri State Conference of the NAACP v. Secretary of State Jay Ashcroft*.

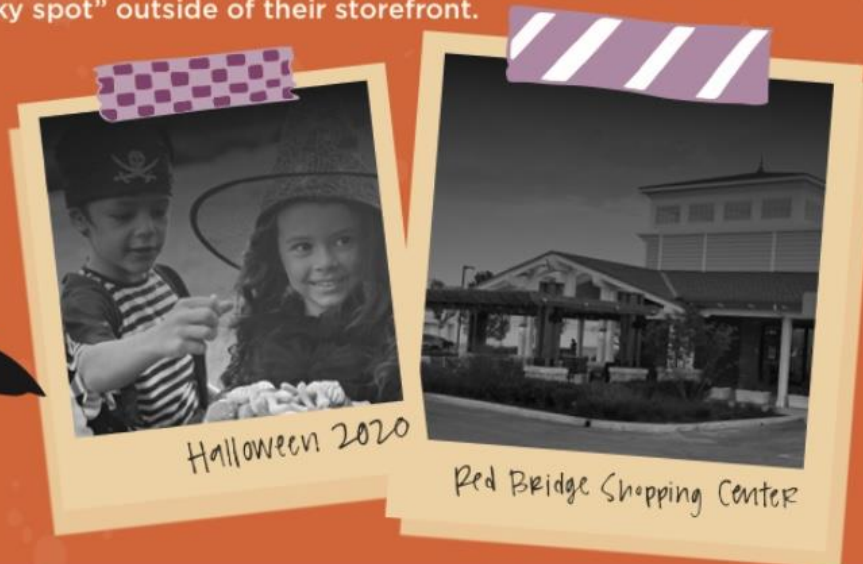

- Take deep breaths as most of us can benefit from taking several deep breaths often throughout the day. This can help move stress out of your body and even help stop a panic attack.
- Listen to music as this helps your body relax naturally.
- Play music timed to breath or your heartbeat. Create a relaxing playlist for yourself and listen to it often.
- Pay attention to your physical self by getting enough sleep and rest each day.
- Eat healthy meals and snacks and drink plenty of water.
- Avoid caffeine, tobacco, and alcohol. Their effects are multiplied under stress and can be harmful.

## Low Income Home Energy Assistance Program (LIHEAP)

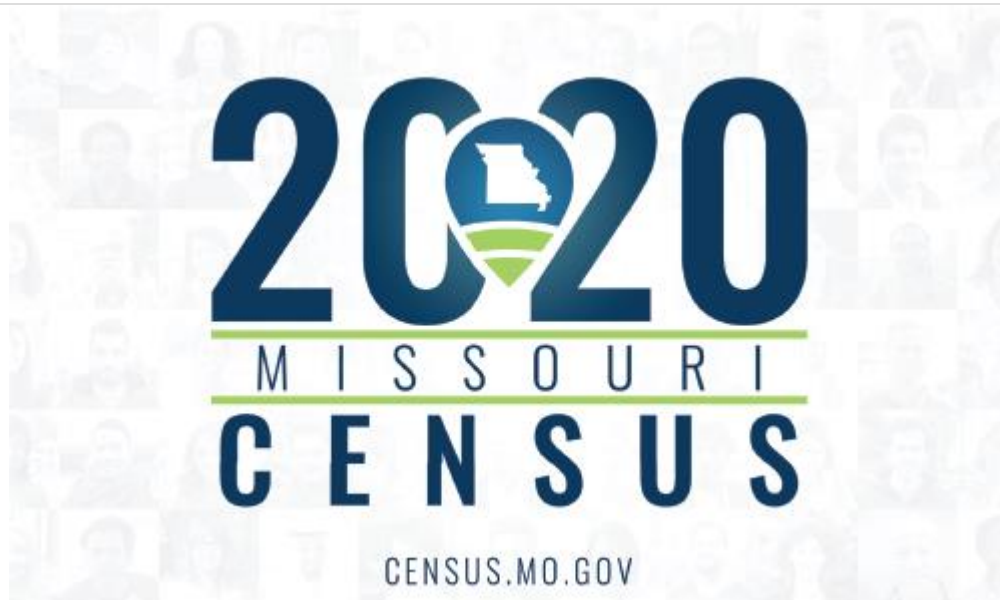

Fortunately, Harvesters (the community food network) brings the semi-truck that serves as its mobile food pantry to four sites in south Kansas City monthly to distribute fresh produce and other healthy food to families in need. The sites are:

**Evangel Church**, 1414 E. 103<sup>rd</sup> St., from 7 to 8:30 a.m. the second Saturday of the month. Persons may remain in their vehicles, and food will be brought to them.

**Ruskin High School**, 7000 E. 111<sup>th</sup> St., from 4 to 5:30 p.m. the third Thursday of the month. Vehicles should line up on Ruskin Way on the east side of the school, and food will be loaded in the vehicles when they reach the school by staff and student volunteers. This event is sponsored by the school and Community Assistance Council.

**Colonial Presbyterian Church**, 9500 Wornall Rd., with registration beginning at 8 a.m. and food distribution running from about 8:30 to 10 a.m. on the third Saturday of the month. Families are asked to bring two cardboard boxes for volunteers to put the food in.

**Martin City K-8 School**, 201 E. 133<sup>rd</sup> St., from 11 a.m. until food runs out on the third Saturday of the month. This event is sponsored by Three Trails Community church.

# UNEMPLOYMENT

## How to File?

If you're eligible, you'll need the following:

1. Your Social Security number;
2. Any amount you were paid in the past week, before taxes and deductions;
3. The name and mailing address of each job you worked in the past 18 months;
4. The dates you started and ended work at each of those jobs.

If this is your first time filing for unemployment please watch [this video](#) on unemployment basics. Visit [uinteract.labor.mo.gov](http://uinteract.labor.mo.gov), create an account and file your claim. If your job loss is related to coronavirus issues, make sure to check a box that says "COVID-19" in your application to waive a requirement to search for a new job amid the crisis.

Missouri provides benefits for up to 20 weeks, which can be extended to 33 weeks under the federal provisions.

The state will pay you up to \$320 per week, and the federal government will provide \$600 on top of whatever you get from the state for each week you're on unemployment prior to July 31.

Benefits can be paid within 22 days unless there is an issue with your eligibility, which on average can take 4-6 weeks to resolve.

You should continue filing weekly requests for payment even if you have not yet received benefits.

**SUBJECT: Reward Increase – 9 Year Old Dominic Young  
Homicide**

**KANSAS CITY, MO --- The Kansas City, Missouri Police Department and the Greater KC Crime Stoppers TIPS Hotline continue to seek information in the January 20, 2018 homicide of 9 year old Dominic Young Jr. at 71 Highway and Emanuel Cleaver II Blvd.**

**Dominic Young Jr. was apparently hit by a stray gunshot while occupying a vehicle driven by his father and died as a result of his injuries. Dominic, his father and brother were en route to Grandview at the time. The vehicle driven by Dominic's father was hit by gunshots from other vehicles apparently engaged in a gunfight according to statements.**

**KCPD found a possible crime scene near the intersection where**

the father said the shooting happened. When the father arrived home in Grandview, Dominic was not responsive. Grandview police initially responded to the father's home and found the boy in critical condition. He was later pronounced dead at a hospital.

A number of community leaders and organizations including State Representative Richard Brown, Mayor Pro Tem Kevin McManus, former City Councilmen Scott Taylor, Scott Wagner, John Sharp; the City of KCMO and Concord Fortress of Hope Church (Pastor Ron Lindsay) have come forward to increase the existing reward in the case up to \$30,000.00. Those leaders are available for comment in regard to the case.
