Neighbor,

My legislative colleagues from our area and I will discuss the major issues that will be considered by the 2021 session of the Missouri General Assembly during a virtual ZOOM webinar **from 6 to 7:30 p.m. Monday, December 14**, sponsored by the South Kansas City Alliance.

We will also discuss our top priorities for the session that begins January 6 and take questions about state issues during the legislative panel discussion. **Please see the SKCA newsletter below for the link and call-in information for the event.**

One of my top priorities will be to pass House Bill 99, the bill I introduced to enact **Blair's Law** to make discharging a firearm with criminal negligence within or into city limits a state offense. It is named after Blair Shanahan Lane, the 11-year-old girl killed here by celebratory gunfire.

I greatly appreciate the KCMO City Council on December 10 approving a resolution that included supporting passage of Blair's Law with the rest of the city's positions on upcoming state legislation.

Reckless celebratory gunfire on certain holidays and special occasions can make some of our neighborhoods sound like war zones. Hopefully enhancing the penalties for such irresponsible behavior as has been done recently in other states such as Arizona and Virginia, coupled with a major public education program about the dangers of reckless gunfire in urban areas, can significantly reduce such gunfire before anyone else is killed.

Governor Mike Parson today signed into law the supplemental spending bill that included \$2 million to fund the legislation I co-sponsored that created a new statewide pretrial witness protection program.

I am urging that this program be quickly implemented to encourage people to testify so that more of the persistent violent offenders who commit many of our city's most violent crimes can be successfully prosecuted and incarcerated before they can hurt more victims.

As of December 10, KCMO had recorded 170 homicides so far this year, far exceeding the highest number of homicides for any year in the city's history (151) set in 2017 and 2019. We all have to do everything in our power to reverse this wave of deadly violence!

LAWS USED TO BLOCK ABORTION VOTE RULED

UNCONSTITUTIONAL

A Cole County judge on Dec. 4 ruled unconstitutional two state statutes Secretary of State Jay Ashcroft invoked last year to block Missouri voters from having a chance to decide whether legislation which criminalized performing most abortions after just eight weeks of pregnancy should become law.

After the Missouri General Assembly enacted House Bill 126 which included other abortion restrictions on the last day of the 2019 legislative session before I took office, opponents of the bill quickly filed a referendum petition, which forces a statewide vote on a bill passed by lawmakers and signed by the governor and prevents it from taking effect unless approved by voters.

Ashcroft initially declared the petition unconstitutional because a portion of HB 126 was subject to an emergency clause causing it to take effect immediately upon being signed by the governor, and the state constitution prohibits referendums on bills that already have become law.

Ruling in a lawsuit brought by petition organizers, the Missouri Court of Appeals said on July 8, 2019, that the secretary of state has no authority to declare petitions unconstitutional and ordered him to certify the petition.

However, Ashcroft didn't immediately do so, noting that state law granted him up to 51 days to complete the job. He finally cleared the petition for circulation on Aug. 14, 2019, just two weeks before the deadline for turning in the more than 100,000 signatures from registered voters required to force HB 126 onto the ballot, a likely impossible task by that point.

Ruling in a follow-up lawsuit to prevent Ashcroft from blocking future referendum attempts, Cole County Judge Jon Beetem noted that for a bill passed on the final day of a legislative session, the deadline for submitting a referendum petition is just 90 days from then, but that the challenged statutes allow state officials to take away up to 51 of those days. As a result, Beetem said those statutes unconstitutionally impede the right of citizens to force statewide votes on legislative acts.

"No pre-circulation presentment to the government is contemplated by the constitution," Beetem wrote. "Bestowing on state officials the authority to derail

the referendum petition process by delaying the certification of an official ballot title is contrary to the plain language of (the constitution) and the primary objectives of the reservation of the referendum power.”

Although Ashcroft successfully stymied the HB 126 referendum, most of the bill’s key provisions have been blocked by a federal judge, who ruled they violate the U.S. Supreme Court landmark decision in *Roe v. Wade* protecting abortion rights.

MEASURE SEEKS REJECTION OF PRESIDENTIAL ELECTION RESULTS

The leadership of the Missouri House of Representatives extended a special legislative session that was expected to end on Dec. 10 to consider a non-binding resolution calling on Congress to reject the presidential election results of six states won by former Vice President Joe Biden.

Sixty-seven House Republicans, including House Majority Leader Rob Vescovo, had signed a letter to departing House Speaker Elijah Haahr, R-Springfield, asking him to extend the special session, which Gov. Mike Parson called last month for lawmakers to enact a supplemental spending bill including funding for the new witness protection program. Vescovo is slated to become Speaker when the regular legislative session begins Jan. 6.

House Resolution 2 introduced by Rep. Justin Hill of St. Charles County cites unsubstantiated claims of voter fraud in Arizona, Georgia, Michigan, Nevada, Pennsylvania and Wisconsin – states won by Biden. A House committee is expected to hear the resolution on Dec. 14, with the full 163-member chamber to convene amid the worsening COVID-19 pandemic to debate the measure shortly thereafter.

The Senate permanently adjourned from the special session on Dec. 10 and will not consider the measure. As a purely symbolic resolution with no force of law, no Senate action on HR 2 is required.

HR 2 was filed one day after Missouri Attorney General Eric Schmitt joined a lawsuit brought by Texas asking the U.S. Supreme Court to directly intervene in the presidential election and throw out the election’s results in four states

carried by Biden – Georgia, Michigan, Pennsylvania and Wisconsin.

To date, no lawsuits challenging the presidential election results in any state have been successful.

NET GENERAL REVENUE COLLECTIONS UP IN NOVEMBER

Net state general revenue collections for November 2020 increased 14.5 percent compared to November 2019, going from \$708.5 million last year to \$811.1 million this year. The boost was driven by strong growth in individual and corporate income tax collections compared to last November.

Year-to-date net general revenue collections through the first five months of the 2021 fiscal year which started July 1 were up 23.3 percent compared to the same period in FY 2020, going from \$3.68 billion last year to \$4.53 billion this year.

However, the year-to-date revenue figures are inflated by the fact that this year's income tax filing deadline was delayed from April to July due to the COVID-19 pandemic, thus pushing revenue that normally would have been collected in FY 2020 into the early months of FY 2021.

Governor Parson Announces FY 2022 Consensus Revenue Estimate

(JEFFERSON CITY, MO) – Today, Governor Mike Parson announced the state’s Consensus Revenue Estimate (CRE) for Fiscal Year 2022.

The annual CRE is a figure established by state budget experts and outside consultants and is one of the basic assumptions used by the Governor and legislative leaders to build and balance Missouri’s budget.

“I want to thank Senator Dan Hegeman and Representative Cody Smith for their hard work and cooperation in developing this revenue estimate,” **Governor Parson** said. “COVID-19 has had an overwhelming impact on our economy, but we are already making a strong recovery and remain optimistic for the coming year. We look forward to working with the General Assembly this session to create a balanced and responsible budget for the people of Missouri.”

The key figure in the CRE is the projected general revenue collections. Net general revenue collections in FY22 are expected to be \$9.78 billion. This represents a net decrease of \$418.8 million over the estimated revenue for FY21.

The estimate for FY22 assumes a decrease of 4.1 percent. The revised estimate for the current fiscal year (FY21) is \$10.2 billion. This estimate is artificially high due to the income tax filing date being moved from April 15 in

FY20 to July 15 in FY21, resulting in two income tax filing dates in FY21. The FY22 estimate reflects a return to a single filing date in the fiscal year.

“I am pleased we were able to arrive at a consensus revenue estimate for FY22. The House, Senate, and Governor stand ready to work together to address the needs of Missourians as we recover from the COVID-19 pandemic,” said **Senator Dan Hegeman, Senate Appropriations Chairman**.

“We are in the midst of the most trying economic times in a generation. Forecasting revenue growth is particularly challenging this year. Therefore, I'm pleased to put forward a conservative revenue estimate to which the House, Senate, and Governor have agreed,” said **Representative Cody Smith, House Budget Chairman**.

Governor Parson will detail his proposed budget for FY22 during the State of the State address in January.

THE FIRST AWARD OF THE MEMORIAL MEDAL OF TREE OF PEACE TO SOUTH KC RESIDENT

Žilina, October 28, 2020. The civic association Servare et Manere, as the responsible organization for the implementation of the international initiative Tree of Peace, had the honour of awarding the Memorial Medal of Tree of Peace to Mr. Ross P. Marine, Honorary Consul of the Slovak Republic to the Midwest USA for noteworthy merit for the implementation of the project in the United States. Thanks to Mr. Marine, it was possible to plant the Tree of Peace in an extremely important place for American and world military history. On Friday, June 21, 2019, at 5:00 pm, [the ninth Tree of Peace](#) was planted on the north lawn of the National World War I Museum and Memorial of the United States in Kansas City in the state of Missouri. The event took place also under the auspices of the Consulate General of the Slovak Republic in New York.

In the United States the project also received the significant honour. Thanks to Mr. Marine's initiative, an official Congressional Record was issued in Washington on June 20, 2019. The Record of the United States House of

Representatives with № 104 was signed by Emanuel Cleaver II, a member of the U.S. House of Representatives.

Servare et Manere expresses the gratitude by awarding a Memorial Medal of Tree of Peace, which may be granted to personalities, who are personally involved in planting, or people and governmental or non-governmental organizations who have made a contribution to spreading ideas of understanding and union among nations, as well as have made a contribution to the spreading and implementation of the project. This award is also given for significant environmental merits leading to sustainable development of human society and use of natural resources. The number of laureates is limited to 60 people including organizations.

The Memorial Medal of Tree of Peace was awarded on September 28, 2020 on the second anniversary of the Tree of Peace initiative and was awarded for the first time since the establishment of this award. Unfortunately, the well-known complications caused by coronavirus COVID-19 pandemic affect all spheres of cultural and social life. For this reason, the award was sent only by post. We believe that the actions of Mr. Ross Marine will be inspiring for other future supporters and friends of the Tree of Peace project. *Once again, cordially congratulations to the laureate!*

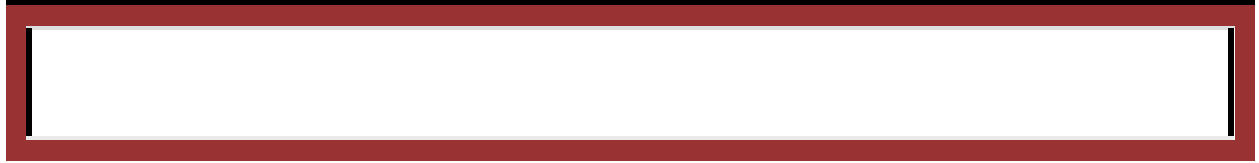

South KC Mobile Food Pantries

With so many people out of work due to the coronavirus pandemic, a growing number of families in south Kansas City are being forced to rely on community food pantries such as Community Assistance Council's to have enough to eat.

Fortunately, Harvesters (the community food network) brings the semi-truck that serves as its mobile food pantry to five sites in south Kansas City monthly to distribute fresh produce and other healthy food to families in need. The sites are:

Center District Warehouse, 8701 Holmes Rd., from 11:30 a.m. to 1:30 p.m. the second Friday of each month. Persons should go to the entrance to the Center Administrative Office and drive through the bus parking lot to the warehouse where volunteers will load the food. Persons should take the Troost Ave exit. The event is sponsored by the Center Education Foundation in partnership with the Center School District.

Evangel Church, 1414 E. 103rd St., from 7 to 8:30 a.m. the second Saturday of the month. Persons may remain in their vehicles, and food will be brought to them.

United Believers Community Church, 5600 E. 112th Terr., with vehicles lining up at 8:30 a.m. and contactless food distribution running from 9 to 11 a.m. the third Wednesday of the month.

Ruskin High School, 7000 E. 111th St., from 4 to 5:30 p.m. the third Thursday of the month. Vehicles should line up on Ruskin Way on the east side of the school, and food will be loaded in the vehicles when they reach the school by

staff and student volunteers. This event is sponsored by the school and Community Assistance Council.

Colonial Presbyterian Church, 9500 Wornall Rd., with registration beginning at 8 a.m. and food distribution running from about 8:30 to 10 a.m. on the third Saturday of the month. Families are asked to bring two cardboard boxes for volunteers to put the food in.

Center High School, 8715 Holmes Rd., from 11 a.m. to 1 p.m. as long as food is left on the third Saturday of the month. The event is sponsored by Three Trails Community church in partnership with the Center School District.

UNEMPLOYMENT

How to File?

If you're eligible, you'll need the following:

1. Your Social Security number;
2. Any amount you were paid in the past week, before taxes and deductions;
3. The name and mailing address of each job you worked in the past 18 months;
4. The dates you started and ended work at each of those jobs.

If this is your first time filing for unemployment please watch [this video](#) on unemployment basics. Visit uinteract.labor.mo.gov, create an account and file your claim. If your job loss is related to coronavirus issues, make sure to check a box that says "COVID-19" in your application to waive a requirement to search for a new job amid the crisis.

Missouri provides benefits for up to 20 weeks, which can be extended to 33 weeks under the federal provisions.

The state will pay you up to \$320 per week, and the federal government will provide \$600 on top of whatever you get from the state for each week you're on unemployment prior to July 31.

Benefits can be paid within 22 days unless there is an issue with your eligibility, which on average can take 4-6 weeks to resolve.

You should continue filing weekly requests for payment even if you have not yet received benefits.
