



Dear Neighbor,

I was extremely disappointed that the Missouri House this week on a near party line vote refused to provide funding for Medicaid expansion after Missouri voters approved adding Medicaid expansion to our state constitution last year.

I am still somewhat hopeful that this decision can be reversed in the Senate and that a majority of House members can be convinced to support funding expansion without having to resort to litigation. The General Assembly cannot overturn a constitutional provision without a vote of the people, and that is essentially what not funding Medicaid expansion is attempting to do.

**On a positive, but much less significant note, I was gratified that the House on March 31 by a vote of 153-0 passed House Bill 100 I introduced with nine bipartisan co-sponsors to establish a special Negro Leagues Baseball Museum license plate to raise awareness of the Museum and funds for its operation.**

The bill had earlier been recommended for passage as a consent bill by a 13-0 vote of the House Transportation Committee and by a 9-0 vote of the House Consent & House Procedure Committee. The bill has been sent to the Senate for consideration.

When enacted into law, the bill will allow persons who make a \$10 contribution to the Museum to purchase a set of the special plates for a

\$15 fee that will be added to their regular license fees. The plates will include the name of the Museum in capital letters and its logo.

Identical legislation has been introduced by Senator Barbara Anne Washington which passed the Senate 34-0 and is awaiting House approval, so the chances of one of these bills becoming law look extremely promising.

## HOUSE REJECTS MEDICAID EXPANSION FUNDING

The Missouri House of Representatives on April 1 passed a \$32 billion state operating budget for the upcoming fiscal year that doesn't fund Medicaid expansion in a last-ditch attempt supported by the House Republican leadership to block a constitutionally mandated expansion of the program's eligibility threshold.

House Democrats made multiple attempts that I supported to restore the funding during debate on March 30, but all but a handful of Republicans opposed those efforts.

Because the state constitution now requires Medicaid to cover adults earning up to 138 percent of the federal poverty level, an estimated 275,000 additional uninsured Missourians will be eligible for the program starting July 1, and opponents can do nothing at this point to stop that. But by refusing to authorize the necessary spending authority for the expansion, it could cause the program to exhaust its funding partway through the 2022 fiscal year, which starts July 1.

**Under the federal Affordable Care Act, the federal government will pay 90 percent of the cost of expansion, or about \$1.4 billion for FY 2022. In addition, Missouri would receive an additional \$1.5 billion under the most recently passed federal COVID-19 relief bill for implementing expansion. Prominent business organizations, including the Missouri Chamber of Commerce and Industry, support accepting the funding because of the massive economic boost and**

**job creation that would result from infusing that much new revenue into the state's economy.**

Gov. Mike Parson included the additional Medicaid funding in his state budget proposal and acknowledged that health care savings resulting from expansion and increased economic activity from the infusion of federal funds would be more than sufficient to cover the state's share.

**If the Senate doesn't restore the funding and it isn't in the approved final budget, a lawsuit to enforce the constitutional requirement is considered almost certain.**

The House's version of the budget includes \$2.27 billion less in spending authority than Parson requested, with the missing Medicaid funding accounting for most of it. The House also failed to include a number of other items requested by the governor, slashing about \$32.5 million in spending for mental health services and more than \$23 million for various education programs.

The House budget does provide sufficient spending authority to claim "full funding" of the statutory formula for distributing state aid to local public school districts. However, that is only because the legislature years ago moved the goal posts on what is considered "full funding" to cap the amount that has to be added to state aid every year that is supposed to cover inflation and other increased costs. The budget also underfunds K-12 school transportation funding by nearly \$183 million from what state law says it should be.

The Senate will craft its own versions of the 13 appropriations bills that make up the operating budget in the coming weeks and is expected to be much more generous in allocating federal coronavirus relief funding that the House left unused. House and Senate negotiators must then hammer out a compromise budget for the two chambers to agree to by the May 7 deadline.

**PRESCRIPTION DRUG MONITORING ADVANCES**

The years-long effort to adopt a statewide prescription drug monitoring program (PDMP) overcame a key hurdle on March 29 when the Missouri Senate granted a PDMP bill preliminary approval.

**Missouri holds the dubious distinction of being the only state in the nation that doesn't have a statewide PDMP, a key tool to identify and reduce opioid dependency and abuse.**

For eight straight years, PDMP legislation routinely passed the House of Representatives only to die in the Senate. But with the bill's previous House sponsor now a senator, the bill started in the upper chamber this year. A second vote is required to advance the measure, Senate Substitute for Senate Bill 63, to the House.

Opponents of a statewide PDMP have steadily lost leverage over the years as many Missouri counties including Jackson County joined a PDMP network started by St. Louis County in response to the legislature's continued inaction. The St. Louis County PDMP now covers about 90 percent of Missouri's population.

## Governor Parson announces special funding cycle to help Missouri's youth

JEFFERSON CITY, Mo. - Today, Governor Mike Parson announced a special cycle of the Department of Economic Development's Neighborhood Assistance Program (NAP) and Youth Opportunities Program (YOP), making \$21.8 million available to assist nonprofit organizations and other entities providing services to at-risk youth.

"Missouri nonprofits have been a lifeline for many Missourians throughout the COVID-19 crisis, providing critical services during times of uncertainty," Governor Parson said. "This program will help ensure that these organizations can continue providing Missouri's at risk-youth with the support and resources they need throughout the recovery process."

COVID-19 has had a massive impact on mental health for all citizens, including children. Anxiety, stress, and other negative conditions have

been on the rise, and these organizations provide resources and services that help children deal with these issues.

Up to \$8 million of NAP tax credits and \$6 million of YOP tax credits will be reserved for nonprofit organizations and other entities providing critical services to at-risk youth. Additional NAP and YOP credits are available for nonprofits addressing other pressing community needs with priority for job training programs and services directly resulting in crime prevention. Nonprofit organizations, faith-based organizations, Missouri businesses, local governments, and schools are all eligible entities for this program.

“Community organizations have played a huge role in supporting hard working Missouri families throughout the pandemic,” Missouri Department of Economic Development Director Rob Dixon said. “We’re proud to be able to use these funds to bolster these great organizations.”

NAP and YOP are contribution tax credit programs. Approved applicants are awarded state tax credits to help attract eligible donors to fund an approved community development or youth opportunity project. Organizations approved for tax credits engage in fundraising activities and offer tax credits as an incentive to donate, raising the dollars necessary to complete the proposed project and address a critical community need.

The application cycle for the NAP/YOP Special Cycle will be held from March 31 to April 22.

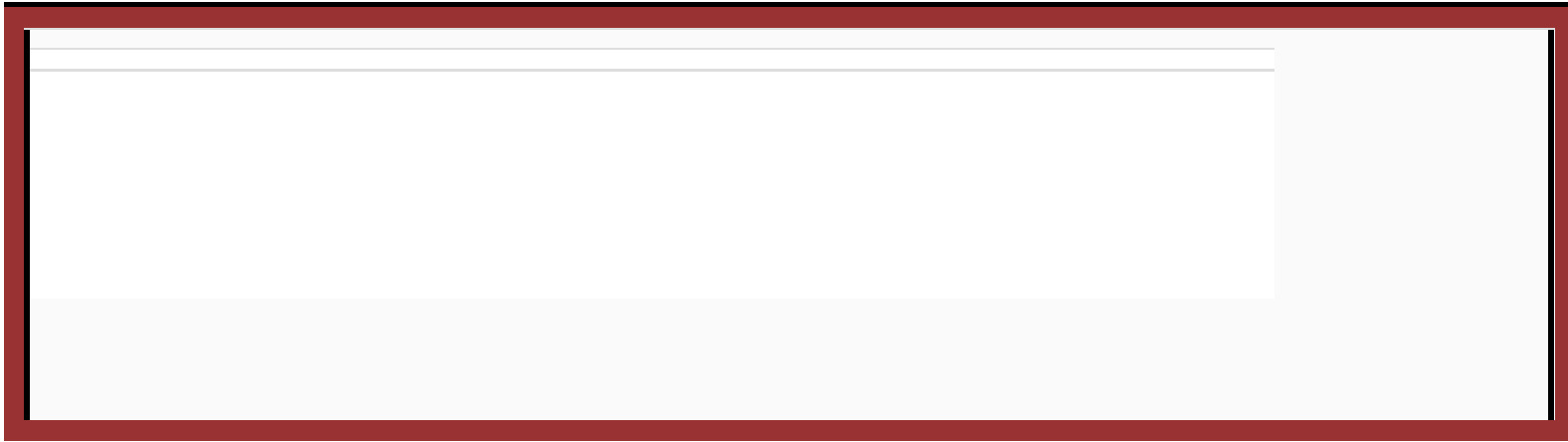
## MISSOURI EMERGENCY RENTAL ARREARS PROGRAM

## South KC Mobile Food Pantries

With so many people out of work due to the coronavirus pandemic, a growing number of families in south Kansas City are being forced to rely on community food pantries such as Community Assistance Council's to have enough to eat.

Fortunately, Harvesters (the community food network) brings the semi-truck that serves as its mobile food pantry to five sites in south Kansas City monthly to distribute fresh produce and other healthy food to families in need. The sites are:

**Center District Warehouse**, 8701 Holmes Rd., from 11:30 a.m. to 1:30 p.m. the second Friday of each month. Persons should go to the entrance to the Center Administrative Office and drive through the bus parking lot to the warehouse where volunteers will load the food. Persons should take the Troost Ave exit. The event is sponsored by the Center Education Foundation in partnership with the Center School District.

**Evangel Church**, 1414 E. 103<sup>rd</sup> St., from 7 to 8:30 a.m. the second Saturday of the month. Persons may remain in their vehicles, and food will be brought to them.

**United Believers Community Church**, 5600 E. 112th Terr., with vehicles lining up at 8:30 a.m. and contactless food distribution running from 9 to 11 a.m. the third Wednesday of the month.

**Ruskin High School**, 7000 E. 111<sup>th</sup> St., from 4 to 5:30 p.m. the third Thursday of the month. Vehicles should line up on Ruskin Way on the east side of the school, and food will be loaded in the vehicles when they reach the school by staff and student volunteers. This event is sponsored by the school and Community Assistance Council.
