Dear Neighbor,

House Bill 66 that I co-sponsored to create a long overdue pretrial witness protection program in Missouri passed the Missouri House of Representatives Tuesday, August 25, by a vote of 147-3. An emergency clause to make it effective as soon as it is signed by the governor passed 118-31.

Naturally, I voted for both measures.

The bill now awaits action by the Missouri Senate which is scheduled for next week.

HB 66 will establish a pretrial witness protection fund that will be administered by the Missouri Department of Public Safety that will provide funding to law enforcement agencies to protect victims, witnesses and their immediate families whenever their testimony in criminal trials would jeopardize their lives.

Agencies will need to apply for funding for specific criminal cases and outline projected costs and how they intend to protect victims or witnesses. Those of us who strongly support the bill hope the governor will call for a special session of the General Assembly to coincide with the September 16 veto session to approve appropriating money for the program.

Another bill I co-sponsored that should greatly reduce the incentive for guilty defendants in murder cases or other serious felonies to try to have witnesses killed before they can testify (or to intimidate them into not testifying) also passed the House 133-11 on August 25. An emergency clause was approved 128-16. I voted for both issues.

House Committee Substitute for House Bill 2 will allow a judge to admit statements by witnesses into evidence if the judge finds (in a hearing outside the presence of the jury in a jury trial) that a defendant engaged in or consented to wrongdoing that caused the unavailability of a witness despite due diligence by the prosecution or the witness is unavailable "because the defendant caused the death of the witness".

Hopefully, these two bills will encourage more victims and witnesses to testify so the small number of persistent violent offenders who commit a high percentage of KCMO's violent crimes can be prosecuted successfully and incarcerated before they can hurt more victims.

This should help reduce our soaring number of homicides in KCMO which totaled 129 for this year on August 27, a 42% increase from the average number of homicides (91) by that date for the last four years. (This is 19 more homicides that the number listed in the August 1 Capitol Report when I first started tracking homicides in this Report.)

# Mark A. Sharp Weekly Capitol Report Friday, August 28th, 2020

#### THREE MORE BILLS AWAITING SENATE ACTION NEXT WEEK

Besides legislation to protect witnesses, three more bills approved by the House this week are scheduled to be considered by the Senate next week.

**House Bill 11** will make it a Class D felony to aid or encourage a child under 17 to commit a state weapons offense. This bill passed the House 117-33, and an emergency clause to make it effective as soon as it is signed by the governor passed 111-39. I voted yes on both issues.

House Committee Substitute for House Bill 16 gutted the original version of this bill that I co-sponsored to make it a Class E felony to knowingly deliver, give, lend or sell a firearm to someone under 18

without the consent of the recipient's custodial parent or guardian.

The committee substitute eliminated the present law making it a Class A misdemeanor to <u>recklessly</u> deliver, give, lend or sell a firearm to persons under 18 without the consent of the recipient's custodial parent or guardian. An amendment to restore this important public safety provision was defeated 41-94. I voted for it.

If this bill passes in its present form, there will be no state law prohibiting individuals from delivering, giving, lending or selling firearms to persons under 18, although federal law prohibits such transfers of handguns by individuals with certain exceptions such as for target practice and hunting.

Ironically, the committee substitute keeps in place the present law making it a Class A misdemeanor to knowingly deliver, give, lend or sell a blackjack to a person under 18 without parental consent.

It also makes it a Class E felony to deliver, give, lend or sell a firearm to a person under 18 to avoid, interfere with or prevent a felony arrest, detention or investigation which is much more narrow in scope than the original bill.

The committee substitute passed the House by a vote of 103-45, but an emergency clause was narrowly defeated 99-49 since an emergency clause requires two-thirds of the 163 members of the House to support it in order to pass. I voted no on both measures.

House Committee Substitute for House Bill 46 will modify the provision in present state law that allows St. Louis City to require that current officers and civilian employees of the St. Louis City Metropolitan Police Department live in the city for at least seven years and to require them to live within an hour's drive from the city limits after seven years of service by eliminating the seven-year residency requirement.

The bill allows the city to re-impose the seven year residency requirement for employees hired after August 31, 2023.

It imposes the same restrictions on city residency requirements for public safety employees of the City Fire Department and Sheriff's Office.

The bill passed the House 117-35 and an emergency clause passed 113-38. I voted no on both issues primarily because the St. Louis City Board of Aldermen have already put an amendment to the city charter on the November ballot to eliminate the residency requirement for all city employees, and I thought this decision should be left to local voters.

A fourth bill that was expected to be voted on by the House this week was not taken up for a vote by the House Republican leadership and now appears dead.

House Committee Substitute for House Bill 12 would have raised the age from 12 to 16 before a juvenile offender could be considered for prosecution as an adult for offenses that would be felonies if committed by adults.

It also mandated that before transferring a juvenile for prosecution as an adult could be considered there would have to be an evidentiary hearing to determine if the preponderance of evidence indicates there is probable cause to believe the juvenile committed the alleged offense.

This bill, which I felt was a big improvement over present law, had been recommended for passage by the House Special Committee on Criminal Justice by a vote of 7-1 and by the House Rules-Administrative Oversight Committee 12-1.

LAWSUIT FILED OVER BALLOT NOTARIZATION REQUIREMENT


A new Missouri law that authorizes a vote-by-mail process for the Nov. 3 election creates an undue burden on voters seeking to avoid coronavirus exposure from crowded polling places by requiring inperson notarization of ballots, according to a lawsuit filed on Aug. 20 in Cole County Circuit Court by a national advocacy group, American Women.

The Republican-controlled legislature passed Senate Bill 631 to expand remote voting options in Missouri just for this year. Although the state has long allowed absentee voting, unlike most states, Missouri requires voters to state a statutorily authorized reason for doing so.

SB 631 expanded options for mail-in absentee voting to include voters especially vulnerable to COVID-19, such as those age 65 or over or those who have certain medical conditions regardless of age.

All other voters can use the newly created vote-by-mail process. However, unlike with absentee ballots, the new mail-in process requires in-person notarization of ballots.

The lawsuit asks a judge to invalidate the notarization requirement, along with other statutory requirements it contends result in inconsistent procedures and voter confusion. The case hadn't yet been set for a hearing as of Aug. 27.





# **UNEMPLOYMENT**

## How to File?

as painlessly as possible.

If you're eligible, you'll <u>need</u> the following:

- 1. Your Social Security number;
- 2. Any amount you were paid in the past week, before taxes and deductions;
- 3. The name and mailing address of each job you worked in the past 18 months;

4. The dates you started and ended work at each of those jobs.

If this is your first time filing for unemployment please watch **this video** on unemployment basics. Visit <u>uinteract.labor.mo.gov</u>, create an account and file your claim. If your job loss is related to coronavirus issues, make sure to check a box that says "COVID-19" in your application to waive a requirement to search for a new job amid the crisis.

Missouri provides benefits for up to 20 weeks, which can be extended to 33 weeks under the federal provisions.

The state will pay you up to \$320 per week, and the federal government will provide \$600 on top of whatever you get from the state for each week you're on umployment prior to July 31.

Benefits can be paid within 22 days unless there is an issue with your eligibility, which on average can take 4-6 weeks to resolve.

You should continue filing weekly requests for payment even if you have not yet received benefits.

# GREATER KANSAS CITY CRIME STOPPERS 816-474-TIPS HOTLINE

**SUBJECT:** Reward Increase – 9 Year Old Dominic Young Homicide

KANSAS CITY, MO --- The Kansas City, Missouri Police Department and the Greater KC Crime Stoppers TIPS Hotline continue to seek information in the January 20, 2018 homicide of 9 year old Dominic Young Jr. at 71 Highway and Emanuel Cleaver II Blvd.

Dominic Young Jr. was apparently hit by a stray gunshot while occupying a vehicle driven by his father and died as a result of his injuries. Dominic, his father and brother were en route to Grandview at the time. The vehicle driven by Dominic's father was hit by gunshots from other vehicles apparently engaged in a gunfight according to statements.

KCPD found a possible crime scene near the intersection where the father said the shooting happened. When the father arrived home in Grandview, Dominic was not responsive. Grandview police initially responded to the father's home and found the boy in critical condition. He was later pronounced dead at a hospital.

A number of community leaders and organizations including State Representative Richard Brown, Mayor Pro Tem Kevin McManus, former City Councilmen Scott Taylor, Scott Wagner, John Sharp; the City of KCMO and Concord Fortress of Hope Church (Pastor Ron Lindsay) have come forward to increase the existing reward in the case up to \$30,000.00. Those leaders are available for comment in regard to the case.
