In May, Missouri Governor, Mike Parson was joined by State Senator, Barbara Washington, State Representative, Mark Sharp and NLBM President, Bob Kendrick, at Kauffman Stadium to sign SB 189, which creates a special Missouri license plate commemorating the NLBM.

It gives motorists the option of donating \$10 to the museum, making them eligible to apply for the specialty license plate. The plate itself requires another \$15 charge on top of the regular license plate registration fee. The law went into effect on August 28th.

The Negro Leagues Baseball Museum can begin collecting the 200 applications for Missouri Personalized and Special License Plate, Form 1716, along with the \$15 specialty plate fee and Emblem Use Authorization Statement (EUAS), for the one-time \$10 donation to the NLBM for each of the 200 applications submitted.

ANNUAL VETO SESSION CONVENES SEPT. 15

Missouri lawmakers will convene for the annual veto session on Sept. 15, but few if any override attempts are expected.

Although a veto session can last up to 10 days under the state constitution, this year's session is expected to be over within a few hours, as is typical in recent years.

Gov. Mike Parson vetoed four of the 48 non-appropriations bills the General Assembly sent to him during the 2021 legislative session. The rejected bills involved measures related to public records,

transportation, public officials and taxation. None of those vetoes are considered especially controversial.

The governor also issued 51 line-item budget vetoes to 12 of the 18 appropriations bills passed this year, eliminating about \$115 million in spending authority authorized by lawmakers in the \$35 billion state operating budget for fiscal year 2022 which began July 1.

Fifteen of those vetoes totaling \$5.42 million involved an employee incentive program Parson had sought for three years but unexpectedly decided to drop after lawmakers finally included it in the budget.

A successful override requires two-thirds majorities in both legislative chambers – 23 votes in the Senate and 109 in the House of Representatives. Republicans outnumber Democrats 24-10 in the Senate and 113-49 in the House, which has one vacant seat last held by a Republican.

CHANGING HEALTH CARE VENDOR BLOCKED

A Cole County circuit judge on Sept. 7 issued a temporary restraining order blocking the state from cancelling its contract with its longtime provider of prison health care services while a lawsuit challenging a new contract with a different vendor is adjudicated.

Judge Dan Green is scheduled to hear the case Nov. 3.

Corizon, a Tennessee-based company, sued the Missouri Office of Administration, which oversees procurement for state agencies, after losing out on a seven-year, \$1.4 billion contract to provide medical care to inmates housed by the state Department of Corrections. Corizon has been the Department's medical provider for nearly three decades.

The company's longstanding relationship with the Department was set to end this year when the state awarded the new contract to Centurion Health based in Virginia. In its lawsuit, Corizon claims there were improprieties in the bid scoring process that unfairly favored Centurion.

The old contract was set to expire June 30, but it was later extended to Oct. 31. Green's order essentially keeps the old contract in place until he rules, which he said he expects to do no later than Nov. 8.

The case is *Corizon v. Office of Administration*.

Missouri task force to conduct second public hearing online on Tuesday to get input on rights of victims of sexual assault

Public hearing focused standards and practices to support sexual assault victims and investigations will be held Sept. 14 from 1 to 3 p.m.

JEFFERSON CITY – The state task force reviewing the treatment and support of sexual assault victims in Missouri will conduct its second public hearing on Tuesday Sept. 14 from 1 to 3 p.m. The Missouri Rights of Victims of Sexual Assault Task Force invites members of the public to listen to the hearing, which will be conducted online. The hearing will focus on standards and practices recommendations to support sexual assault victims and conduct investigations.

Each of the remaining hearings will also focus on a specific topic and be held from 1 to 3 p.m. on the following dates: Sept. 22 (Survivor Privacy); and Sept. 28 (Evidence Collection). The task force is also seeking comments and suggestions from the public on how to strengthen protections and services for Missouri sexual assault victims. Comments and suggestions are being gathered through an online survey at <https://www.surveymonkey.com/r/MORightsTaskForce>. The survey closes Sept. 30, 2021.

The Missouri Rights of Victims of Sexual Assault Task Force was created through Senate Bill 569, which was signed into law by Governor Mike Parson in July 2020. In addition to including the “Justice for Survivors Act” and the “Sexual Assault Survivors’ Bill of Rights,” it mandated establishment of the task force, which must “collect feedback from stakeholders, practitioners, and leadership throughout the state and local law enforcement, victim services, forensic science practitioners, and health care communities to inform development of future best practices or clinical guidelines regarding the care and treatment of survivors.”

SB 569 also requires the task force to study nationally recognized best practices and make recommendations regarding the development and implementation of a method for tracking and investigating complaints about the handling of sexual assault investigations and reporting, and the development of documentation to be provided to sexual assault survivors informing them of their rights. It also directs the task force to

determine when there is a need for additional employees or volunteers at rape crisis centers, determine the costs of meeting the potential need and methods for meeting the need.

The task force is required to submit a report on its findings, including any majority and dissenting opinions to the Governor and General Assembly by Dec. 31, 2021. The Department of Public Safety is tasked with providing administrative support to the task force.

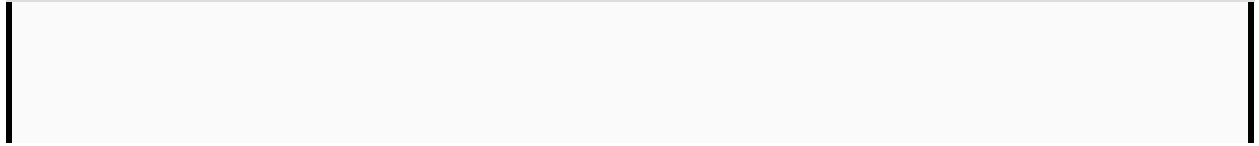

Important SNAP/Food Stamp dates to remember

The Department of Social Services (DSS) is taking extra steps to keep SNAP/Food Stamp recipients aware of upcoming changes and to ease the return to regular SNAP program benefits and operation.

*Starting October 1, 2021, regular SNAP benefit amounts will increase. The regular SNAP maximum benefit amount a family of four can receive in September (which includes the temporary 15 percent increase) is \$782 and starting October 1, that amount increases to \$835.

South KC Mobile Food Pantries

Many families in south Kansas City are being forced to rely on community food pantries such as Community Assistance Council's to have enough to eat.

Fortunately, Harvesters (the community food network) brings the semi-truck that serves as its mobile food pantry to seven sites in south Kansas City monthly to distribute fresh produce and other healthy food to families in need. The sites are:

Center District Warehouse, 8701 Holmes Rd., from 11:30 a.m. to 1:30 p.m. the second Friday of each month. Persons should go to the entrance to the Center Administrative Office and drive through the bus parking lot to the warehouse where volunteers will load the food. Persons should take the Troost Ave exit. The event is sponsored by the Center Education Foundation in partnership with the Center School District.

Evangel Church, 1414 E. 103rd St., from 7 to 8:30 a.m. the second Saturday of the month. Persons may remain in their vehicles, and food will be brought to them.

United Believers Community Church, 5600 E. 112th Terr., with vehicles lining up at 8:30 a.m. and contactless food distribution running from 9 to 11 a.m. the third Wednesday of the month.

Ruskin High School, 7000 E. 111th St., from 4 to 5:30 p.m. the third Thursday of the month. Vehicles should line up on Ruskin Way on the east side of the school, and staff and students will load the food when vehicles reach the school.

Colonial Presbyterian Church, 9500 Wornall Rd., with registration beginning at 8 a.m. and food distribution running from about 8:30 to 10 a.m. on the third Saturday of the month. Families are asked to bring two cardboard boxes for volunteers to put the food in.

Center School District, 8701 Holmes Rd., from 11 a.m. to 1 p.m. as long as food is left on the third Saturday of the month. Persons should drive through the bus parking lot to the district warehouse. The event is sponsored by Three Trails Community church in partnership with the Center School District.

Red Bridge United Methodist Church, 636 E. 117th St., from 2:30 to 3:30 p.m. the fourth Friday of the month in the church parking lot.
