







Dear Neighbor,

Please scroll down and read today's Weekly Update about the legislative proposals aimed at reducing violent crime (including three proposals I have co-sponsored) that will be considered by House committees Monday.

I am hopeful that some of these proposals, particularly the bill I cosponsored to establish a long-overdue witness protection program in Missouri, will put a damper on our skyrocketing number of homicides in KCMO.

As of yesterday, KCMO had recorded 124 homicides this year, including 16 in South Patrol. This is 8 more homicides in the city than reported in last week's Capitol Report and 14 more than reported in the August 1 Report. It also represents a 50% increase from the average number of homicides in the city by the same date for the last 4 years.

Providing protection to witnesses as the federal government and some

other states have done for years will encourage more people to testify about murders and other violent crimes which will help take violent repeat offenders off the streets so they can't harm move victims.

Also please scroll down for more information about important upcoming local events including a hearing at 6 p.m. Monday, August 17, at the First Baptist Church of Kansas City, 100 W. Red Bridge Road (on the northwest corner of Red Bridge & Wornall Roads) by representatives of the city's Public Improvements Advisory Committee (PIAC).

The meeting will hear requests to fund neighborhood capital improvement projects such as park amenities, sidewalks, storm drainage improvements and street widening in the 6th Council District which includes almost all of the 36th House District.

Persons may present their requests in person or virtually via ZOOM. They may contact the PIAC staff at PIAC@kcmo.org or 816-513-8828 beforehand to get the ZOOM link or call 312-626-6799 when the meeting starts and enter the conference ID 99993086422 and passcode 327522.

The deadline to submit a PIAC request for the city's 20-21 fiscal year is August 31.

HOUSE STARTS OVER ON ANTI-CRIME LEGISLATION

Rather than taking up an omnibus anti-crime bill passed last Friday by the Senate that included all the topics that Governor Mike Parson originally put on the agenda for the current special session of the Missouri General Assembly, the House Republican leadership has scheduled hearings on six different bills (including three I co-sponsored) that individually address the topics on the governor's original agenda.

I favored this approach all along since I quickly learned after taking office in January that omnibus bills often contain measures that I think represent good public policy and other measures that I think represent bad policy, forcing legislators to judge whether the good outweighs the bad or vice versa in determining how to cast their vote.

The three bills I co-sponsored are:

House Bill 2 which provides that if a court finds in a hearing outside the presence of the jury that a defendant engaged in or consented to wrongdoing to prevent a witness from testifying and the witness fails to appear that a written statement from the witness may be admitted into evidence. This will eliminate the incentive for defendants in murder

cases or other extremely serious felonies from trying to have witnesses killed before their cases come to trial or trying to intimidate them into not testifying.

House Bill 16 adds a new provision to the law against unlawful transfer of weapons making it a Class E felony to **knowingly** deliver, give, lend or sell a firearm to someone under 18 without the consent of the recipient's custodial parent or guardian. It is already a Class A misdemeanor to **recklessly** do this, but this legislation stiffens the penalty for those who actually **know** the recipient is under 18 and the custodial parent or guardian has not consented.

House Bill 66 which I consider the most important of all the bills under consideration which would finally establish a long overdue pretrial witness protection program in Missouri which both Mayor Quinton Lucas and I asked the governor to put on the agenda for the special session. As I have said repeatedly, persons should not have to risk their lives and the safety of their families to be a witness!

House Bills 2 and 66 will be heard by the House Judiciary Committee at noon Monday, and House Bill 16 will be heard at the same time by the House General Laws Committee.

Other bills that will be heard Monday are:

House Bill 11 to add a provision to the law against endangering the welfare of a child to make it a Class D felony to aid or encourage a child under 17 to commit a weapons offense. This will be heard by the General Laws Committee.

House Bill 46 to repeal the city residency requirement for St. Louis City Metropolitan Police Department employees, but allow a requirement that they live within an hour's drive of the city limits. This will be heard by the Judiciary Committee.

House Bill 12 which raises the minimum age from 12 to 14 when a juvenile can be transferred for prosecution in the adult court system for

commission of an offense that would be a felony if committed by an adult. Juvenile court judges now can schedule a hearing to consider such a transfer and approve the transfer to adult court if they rule the juvenile is beyond rehabilitation through the juvenile justice system. Transfer hearings are required for extremely serious offenses such as murder, forcible rape and armed robbery, and this bill adds unlawful use of a weapon and committing a felony through the use of a dangerous instrument or deadly weapon (armed criminal action) to the list of offenses that automatically trigger such a hearing. This will be heard at 2 p.m. Monday by the Special Committee on Criminal Justice.

After the Senate passed the omnibus measure, the House was expected to follow suit on Aug. 12, thus ending the session.

However, Parson's Aug. 10 decision to expand the session's scope to include legislation authorizing the attorney general to prosecute murder cases and any other crimes that were part of the same course of conduct in St. Louis City if requested by the city's chief law enforcement officer and if the St. Louis City Circuit Attorney has not filed charges within 90 days prompted House Republican leaders to hit the reset button.

Parson has been highly critical of St. Louis City Circuit Attorney Kim Gardner, the only elected African-American female prosecutor in Missouri, about increasing violent crime in the city, while ignoring the impact of changes to greatly relax state gun laws that Parson himself championed as a lawmaker.

When House Speaker Elijah Haahr, R-Springfield, referred the new special session House bills to committee on Aug. 12, he excluded the St. Louis prosecutor bill. As a result, it doesn't currently appear the proposal will advance in the House, although it might be amended on to another bill.

Later that day, the Missouri Association of Prosecuting Attorneys, which represents the state's elected prosecutors, issued a statement opposing the governor's proposal.

"Over the decades, numerous attempts to grant additional original jurisdiction to the Attorney General have been proposed," the statement said. "When those proposals were fully vetted through the deliberative legislative process of a regular session of the House and Senate, they have been consistently rejected. Our system, which for 145 years has provided for independent local prosecutors, should not be abrogated in the rush of a special session."

The House is now scheduled to take final votes on the other bills on Aug. 25.

If the House approves the bills, they will still need to clear the Senate, which had to overcome a 12-hour filibuster to advance the omnibus legislation.

ST. LOUIS SCHOOL RETIREMENT SYSTEM LOSES CASE

The Missouri Court of Appeals Eastern District on Aug. 11 ruled the Public School Retirement System of the City of St. Louis doesn't enjoy the protection of the state's Hancock Amendment and rejected the system's challenge to a 2017 state law that it contended imposed an unconstitutional unfunded mandate on it.

The retirement system challenged a provision of a bill enacted in 2017 authorizing St. Louis Public Schools educators to become eligible for benefits earlier than previously allowed. Since the legislature didn't provide an appropriation to implement the change, the system argued the bill imposed an unfunded mandate.

One provision of the Missouri Constitution's Hancock Amendment prohibits the General Assembly from imposing unfunded mandates on "counties or other political subdivisions." The amendment defines "other political subdivisions" to include municipalities, schools districts and various other entities "having the power to tax." The retirement system has no authority to levy taxes and instead receives its funding from the St. Louis School District.

"In sum, because the Retirement System does not have the power to tax, it is not an 'other political subdivision' within the meaning of Article X, Section 15, and as such, is not entitled to the protections of the Hancock Amendment," Judge Michael Gardner wrote for the unanimous three-judge appellate panel.

The retirement system, which also lost at the circuit court level, can still appeal to the Missouri Supreme Court.



Public Improvement Advisory Committee (PIAC) Hearings

PIAC Public Hearings

The Public Improvements Advisory Committee (PIAC), in cooperation with the Mayor and City Council, will be holding public hearings across the city. These hearings are being held so that the Committee and Council can hear from citizens about the city's public improvements needs. The PIAC will use information gathered through the hearings to recommend projects for funding to the Council for Year Thirty- Eight (Fiscal Year 2021-22) of the one-cent sales tax for public improvements

.

Due to the COVID-19 outbreak, PIAC is modifying the public hearing process to include a remote meeting in each district. Two hearings will be held for each district and will include one virtual meeting and one inperson meeting. The PIAC is making a full effort to ensure that all those who wish to participate in the PIAC district hearings are able to do so in a safe manner. If you have further questions or concerns, please contact PIAC@kcmo.org. Each district's PIAC representatives are also available for contact and further information. 

UNEMPLOYMENT

How to File?

If you're eligible, you'll need the following:

- 1. Your Social Security number;
- 2. Any amount you were paid in the past week, before taxes and deductions;
- The name and mailing address of each job you worked in the past 18 months;
- 4. The dates you started and ended work at each of those jobs.

If this is your first time filing for unemployment please watch **this video** on unemployment basics. Visit <u>uinteract.labor.mo.gov</u>, create an account and file your claim. If your job loss is related to coronavirus issues, make sure to check a box that says "COVID-19" in your application to waive a requirement to search for a new job amid the crisis.

Missouri provides benefits for up to 20 weeks, which can be extended to 33 weeks under the federal provisions.

The state will pay you up to \$320 per week, and the federal government will provide \$600 on top of whatever you get from the state for each week you're on umployment prior to July 31.

Benefits can be paid within 22 days unless there is an issue with your eligibility, which on average can take 4-6 weeks to resolve.

You should continue filing weekly requests for payment even if you have not yet received benefits.

SUBJECT: Reward Increase – 9 Year Old Dominic Young

Homicide

KANSAS CITY, MO --- The Kansas City, Missouri Police Department and the Greater KC Crime Stoppers TIPS Hotline continue to seek information in the January 20, 2018 homicide of 9 year old Dominic Young Jr. at 71 Highway and Emanuel Cleaver II Blvd.

Dominic Young Jr. was apparently hit by a stray gunshot while occupying a vehicle driven by his father and died as a result of his injuries. Dominic, his father and brother were en route to Grandview at the time. The vehicle driven by Dominic's father was hit by gunshots from other vehicles apparently engaged in a gunfight according to statements.

KCPD found a possible crime scene near the intersection where the father said the shooting happened. When the father arrived home in Grandview, Dominic was not responsive. Grandview police initially responded to the father's home and found the boy in critical condition. He was later pronounced dead at a hospital.

A number of community leaders and organizations including State Representative Richard Brown, Mayor Pro Tem Kevin McManus, former City Councilmen Scott Taylor, Scott Wagner, John Sharp; the City of KCMO and Concord Fortress of Hope Church (Pastor Ron Lindsay) have come forward to increase the existing reward in the case up to \$30,000.00. Those leaders are available for comment in regard to the case.
