I recently spoke with Governor Parson about the increased violence in Kansas City and the need to do more to curb this trend. The proposed legislation for the special session is a start, however, much more needs to be done as preventative measures to crime rather than focusing on increasing criminal penalties.

SPECIAL SESSION CALLED

The Governor has called a Special Session to address violent crime in Missouri starting next Monday, July 27. The special session is narrowly tailored to specific subjects set forth by the Governor. You can read his proclamation here.

I plan on filing the same two bills that I filed during this past regular session of the Missouri House of Representatives.

HB 1260 - This bill modifies the categories of persons who cannot possess firearms so that Missouri law conforms with federal law. The bill specifies that any person who has been convicted in any court of a misdemeanor crime of domestic assault, any person who is illegally or unlawfully in the United States, any person who was once a United States citizen but has renounced that citizenship, or any person subject to certain court orders relating to domestic violence cannot possess a firearm.

<u>HB 1261</u> - Repeals provisions that prohibit political subdivisions from adopting orders, ordinances, or regulations relating to firearms.

*Note: These bills will have new numbers for the special session

Kansas City has had 106 homicides in 2020, which is about a 35 percent increase from last year..

Bills Signed/Vetoed:

Last week was the deadline for the Governor to sign bills, and he signed most of them. I am very happy he signed child protection bills and sexual assault survivor bills that will improve things for foster children and for sexual assault victims.

Governor Parson vetoed two bills: <u>HB 1854</u>, an omnibus bill relating to political subdivisions; and <u>SB 718</u>, which related to military affairs and established a Department of Military Forces in Missouri.

COURTS CLEAR MEDICAID EXPANSION FOR AUG. 3 BALLOT

A Missouri court on June 8 ruled against two conservative groups' attempts to block voters from considering a proposed constitutional amendment on Medicaid expansion that will appear on the Aug. 4

statewide ballot. Hours after the second adverse ruling, the Missouri Supreme Court issued an order declining to hear the case on appeal, bringing it a swift and final resolution.

OVERVIEW:

Amendment 2 seeks to constitutionally establish the state's income eligibility threshold for qualifying for Medicaid, known in Missouri as MO HealthNet, at 138 percent of the federal poverty level in accordance with the federal Patient Protection and Affordable Care Act. It will appear on the Aug. 4 statewide ballot and, if ratified, is expected to extend health care coverage to more than 230,000 Missourians who don't currently have it.

For states that expand eligibility, the federal government pays for 90 percent of the cost, with the state picking up the remaining 10 percent. Currently, the federal government pays about 65 percent of cost of Medicaid in Missouri while the state pays about 35 percent. So, the financial terms of expansion are much more favorable to the state.

While MO HealthNet provides free coverage to children in families whose household income is as much as 150 percent of the federal poverty level, their parents only get coverage if the family's income is at or below 19 percent of the federal poverty level, or \$4,052 a year for a family of three. Able-bodied adults with no children are ineligible for MO HealthNet, regardless of their income.

Expanding Medicaid eligibility to 138 percent of the federal poverty level would extend coverage to those who earn up to \$17,236 a year as a single person or \$28,676 annually for a family of three.

Missouri is one of only 14 states that hasn't implemented Medicaid expansion.

The ballot language prepared for Amendment 2 by the Secretary of State's Office, followed by the official fiscal estimate prepared by the State Auditor's Office, says:

Amendment 2 - Medicaid Expansion

Official Ballot Title:

Do you want to amend the Missouri Constitution to:

- 1. adopt Medicaid Expansion for persons 19 to 64 years old with an income level at or below 133% of the federal poverty level, as set forth in the Affordable Care Act;
- prohibit placing greater or additional burdens on eligibility or enrollment standards, methodologies or practices on persons covered under Medicaid Expansion than on any other population eligible for Medicaid; and
- 3. require state agencies to take all actions necessary to maximize federal financial participation in funding medical assistance under Medicaid Expansion?

State government entities are estimated to have one-time costs of approximately \$6.4 million and an unknown annual net fiscal impact by 2026 ranging from increased costs of at least \$200 million to savings of \$1 billion. Local governments expect costs to decrease by an unknown amount.

Fair Ballot Language:

A "yes" vote will amend the Missouri Constitution to adopt Medicaid Expansion for persons 19 to 64 years old with an income level at or

below 133% of the federal poverty level, as set forth in the Affordable Care Act. Currently, Medicaid eligibility is set forth in state statute, but this amendment adds Medicaid Expansion to our constitution. This amendment prohibits placing greater or additional burdens on eligibility or enrollment standards, methodologies or practices on persons covered under Medicaid Expansion than on any other population eligible for Medicaid. The amendment requires state agencies to take all actions necessary to maximize federal financial participation in funding medical assistance under Medicaid Expansion. Federal law requires states to fund a portion of the program in order to receive federal funding (state match). This amendment does not provide new state funding or specify existing funding sources for the required state match.

A "no" vote will not amend the Missouri Constitution to adopt Medicaid Expansion.

If passed, this measure has no direct impact on taxes.


Free online classes available to Missourians unemployed by coronavirus outbreak



SUBJECT: Reward Increase – 9 Year Old Dominic Young Homicide

KANSAS CITY, MO --- The Kansas City, Missouri Police Department and the Greater KC Crime Stoppers TIPS Hotline continue to seek information in the January 20, 2018 homicide of 9 year old Dominic Young Jr. at 71 Highway and Emanuel Cleaver II Blvd.

Dominic Young Jr. was apparently hit by a stray gunshot while occupying a vehicle driven by his father and died as a result of his injuries. Dominic, his father and brother were en route to Grandview at the time. The vehicle driven by Dominic's father was hit by gunshots from other vehicles apparently engaged in a gunfight according to statements.

KCPD found a possible crime scene near the intersection where the father said the shooting happened. When the father arrived home in Grandview, Dominic was not responsive. Grandview police initially responded to the father's home and found the boy in critical condition. He was later pronounced dead at a hospital.

A number of community leaders and organizations including State Representative Richard Brown, Mayor Pro Tem Kevin McManus, former City Councilmen Scott Taylor, Scott Wagner, John Sharp; the City of KCMO and Concord Fortress of Hope Church (Pastor Ron Lindsay) have come forward to increase the existing reward in the case up to \$30,000.00. Those leaders are available for comment in regard to the case.
