*Dear Neighbor,*

This was an abbreviated week in the House as session was cancelled on Monday and Tuesday due to inclement weather. We reconvened on Wednesday and Thursday to work on legislation in various committees.

A bi-partisan bill was advanced in committee to prevent nearly 46,000 Missourians from being forced to repay as much as \$150 million in mistakenly paid Missouri unemployment benefits that were received by recipients through no fault of their own. Much of the money came from the Federal CARES Act that has a provision that allows states to waive overpayments that are not related to fraudulent claims.

I have fought for the people of our state who have fallen into this category because the intent of these federal funds was to give relief to those families who were in financial dire due to the loss of jobs during the pandemic. These funds were given to by the federal government to stimulate the economy of our nation and many of those persons that received the money simply don't have it to repay. I have one



constituent in particular that is being asked to repay nearly \$24,000 that she received through no fault of her own. The state has admitted it was their error in sending out the payments and is now demanding repayment. **THIS IS WRONG!**

I continue to be your voice in Jefferson City and will do what I believe is right for our citizens. If you are one of these individuals affected by the overpayments, I would like to hear from you. Continue to stay safe and warm and know that I am here for you.

**COMMITTEE PASSES BILL TO ADDRESS  
BENEFIT OVERPAYMENTS**

A House committee on Feb. 17 voted 7-1 to advance bipartisan legislation to block Gov. Mike Parson's administration from forcing tens of thousands of unemployed Missourians to collectively repay as much as \$150 million in excess benefits the administration mistakenly paid out last year as unemployment skyrocketed due to the pandemic.

The Missouri Department of Labor and Industrial Relations has admitted that 97.7 percent of the overpayments did not involve fraud and instead resulted from mistakes by the department. The overpayments largely involved federal pandemic funds, and the Federal Department of Labor has authorized states to waive repayment from people who, through no fault of their own, were given excess benefits.

House Bill 1083, which combined similar bills filed by both Democrats and Republicans, would require the department to forgo the recovery of non-fraudulent overpayments of federal unemployment funds. The committee also voted 7-1 to pass House Concurrent Resolution 30, a Democratic proposal urging the Parson administration to waive repayment on his own authority without requiring a change in state law. To date, the governor has insisted the excess benefits must be repaid, even though many recipients lack the means to do so.

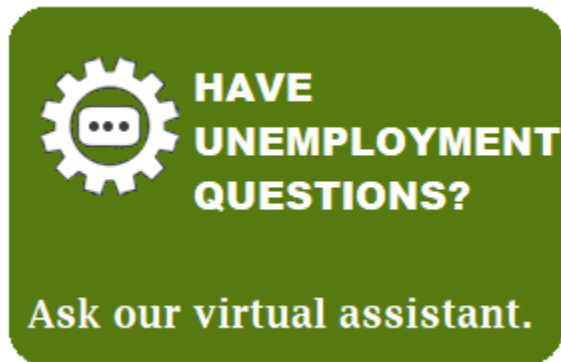



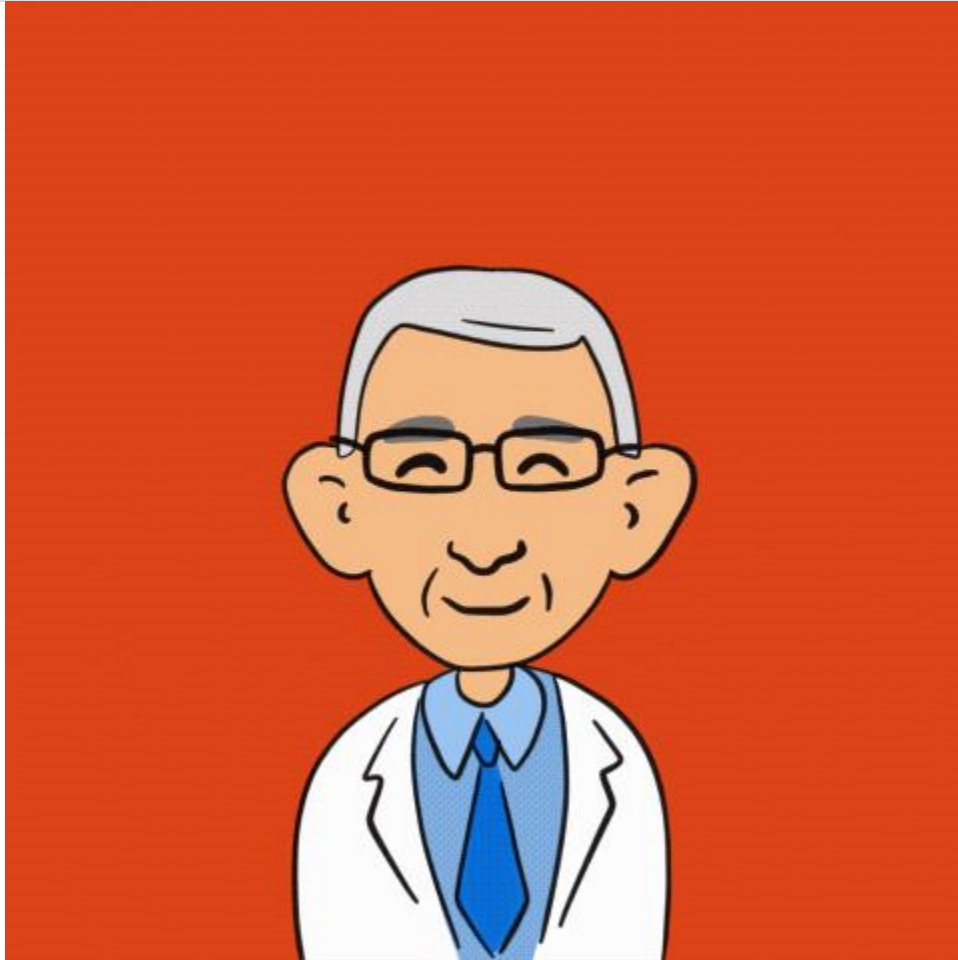

**SUBJECT: Reward Increase – 9 Year Old Dominic Young Homicide**

**KANSAS CITY, MO --- The Kansas City, Missouri Police Department and the Greater KC Crime Stoppers TIPS Hotline continue to seek information in the January 20, 2018 homicide of 9 year old Dominic Young Jr. at 71 Highway and Emanuel Cleaver II Blvd.**

**Dominic Young Jr. was apparently hit by a stray gunshot while occupying a vehicle driven by his father and died as a result of his injuries. Dominic, his father and brother**

were en route to Grandview at the time. The vehicle driven by Dominic's father was hit by gunshots from other vehicles apparently engaged in a gunfight according to statements.

KCPD found a possible crime scene near the intersection where the father said the shooting happened. When the father arrived home in Grandview, Dominic was not responsive. Grandview police initially responded to the father's home and found the boy in critical condition. He was later pronounced dead at a hospital.

A number of community leaders and organizations including State Representative Richard Brown, Mayor Pro Tem Kevin McManus, former City Councilmen Scott Taylor, Scott Wagner, John Sharp; the City of KCMO and Concord Fortress of Hope Church (Pastor Ron Lindsay) have come forward to increase the existing reward in the case up to \$30,000.00. Those leaders are available for comment in regard to the case.
