## Parson emphasizes workforce development, infrastructure in annual speech

JEFFERSON CITY, Mo. — In his address before the General Assembly Wednesday — [derailed at the eleventh hour due to COVID-19 concerns](#) — Gov. [Mike Parson](#) promised a continued focus on workforce development and infrastructure. Parson formally addressed the legislature for the first time in his full term as the 57th governor of Missouri, outlining his priorities going into 2021 from [the Senate](#) after the upper chamber adjourned for the day. He had been originally scheduled to present his State of

the State address from the [House chambers](#) to a joint session, but those plans were curtailed just hours before the event.

“Time and time again, our administration has addressed the challenges of our communities and our state head-on rather than leaving them for another day, another administration, or another generation,” Parson said. “It is important that we continue to follow through on key investments in workforce development and infrastructure. We must also continue finding ways to strengthen public safety, improve health care, and make state government more accountable.”

House members were not given official guidance on how or where to watch the speech but a handful did trickle into the Senate’s fourth-floor gallery in seats marked to maintain social distance.

The Missouri Housing Development Commission (MHDC), in conjunction with the Missouri Department of Social Services will make CARES Act COVID-19 Emergency Solutions Grant (ESG-CV) funds available for emergency rental arrears assistance.

The Missouri Emergency Rental Arrears Program (ERAP) provides financial support for landlords and renters who are struggling due to the COVID-19 emergency in the State of Missouri. The program will reimburse landlords for past due rent payments (rental arrears) for the period beginning April 1, 2020. Applications must be completed and submitted by landlords in collaboration with their tenant. A one-time payment of up to six (6) months of rental arrears will be made to the landlord on the tenant's behalf. Requests are subject to the established rent maximums outlined below.

## COVID-19 Vaccine Availability

### PHASE 1A

Long-Term care facility residents and staff

Healthcare workers (patient facing)

Emergency medical services (EMS)

### PHASE 1B

High-risk individuals (18-64) and individuals >65

First responders (see below)

Essential workers (see below)

### PHASE 2

Populations at increased risk (prisoners, homeless, etc.)

### PHASE 3

All Missouri residents

### Healthcare Workers

Healthcare personnel and staff who may have direct or indirect exposure to SARS-CoV-2 and are unable to work from home. This may include workers at:

- Skilled nursing facilities
- Residential care facilities
- Long-term care facilities
- Assisted living
- Inpatient and outpatient facilities

### Essential Workers

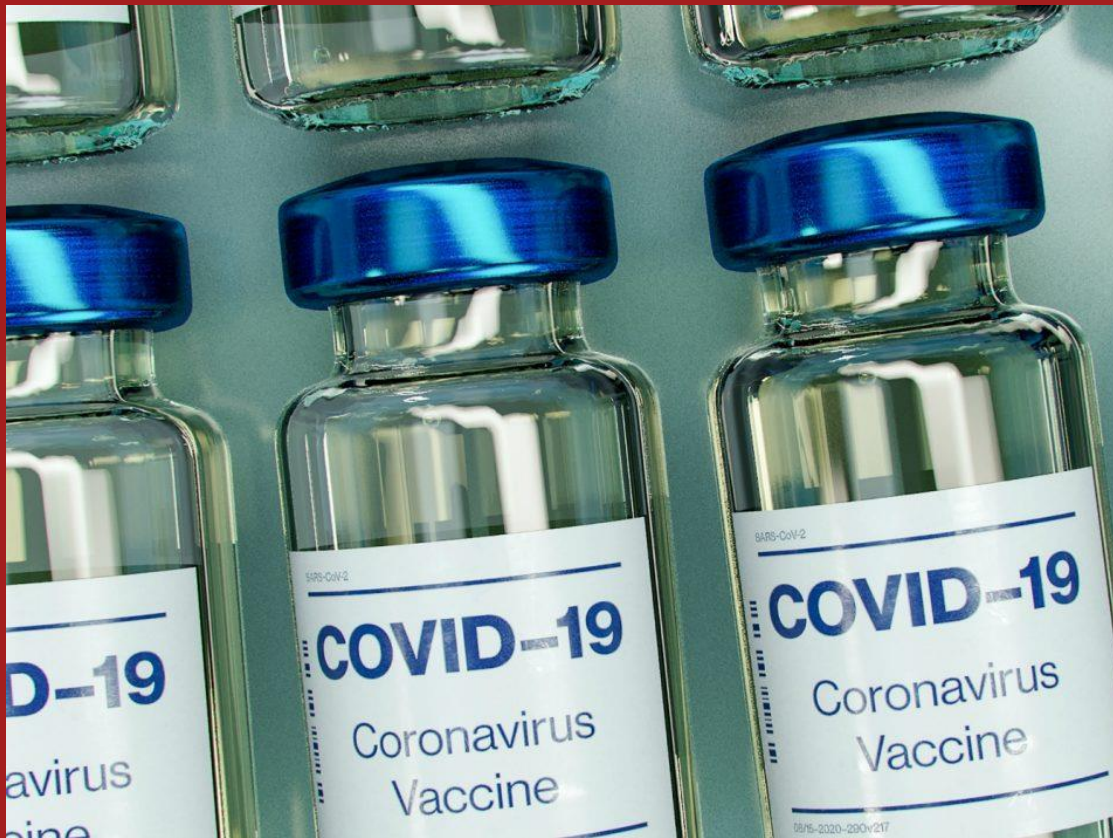
- Public-facing healthcare
- First responders
- Childcare workers
- Teachers & education staff
- Energy workers
- Critical manufacturing workers
- Food & agriculture workers

### High Risk Populations

Those at increased risk for severe COVID-19 illness, including those 65 years of age or older, may receive priority:

- BMI >30
- Chronic kidney disease
- Chronic obstructive pulmonary disease
- Hypertension
- Chronic heart disease





## Vaccine Survey Tool from Jackson County, MO

The Jackson County Health Department is following the [state of Missouri's COVID-19 vaccine distribution plan](#).

The time it takes to make a COVID-19 vaccine available to everyone who wants one is dependent on a few factors.

1. The supply of vaccine provided by the state of Missouri to administrators in our area.
  2. Where residents fall within the [phased distribution plan](#).
- The first phase focuses on (1A) long-term care facility residents and staff, patient-facing healthcare workers, and (1B) high-risk individuals, first responders, and essential workers.

- The state will not move to the next phase until the vaccine is made available to all individuals in the previous phase who want one.

The survey asks for contact information, occupation, and pre-existing medical conditions. Responses from the survey will help us determine which phase of the state's vaccination plan residents fall under. All individuals who live or work in Jackson County and are interested in receiving the vaccine are encouraged to fill out the survey [here](#).

## Rick Brattin, Missouri Senator, Pushes State Bill To Allow Deadly Force Against Protesters

A Missouri state senator has put forward a bill that would allow the use of deadly force against protesters on private property.

The proposal, sponsored by Republican Sen. Rick Brattin, would also make people who run over demonstrators blocking traffic not liable for any injuries sustained.

"To think that your right to protest enables you the right to stop traffic and literally stop people's ability to move about freely in this nation is a gross misunderstanding of our constitutional rights," Brattin said during a hearing on Monday.

Brattin explained that blocking traffic can be dangerous if it stops ambulances or police from responding to emergencies.

## Missouri officials to receive first salary increase in more than a decade

JEFFERSON CITY, Mo. — Missouri officials are receiving their first pay raise in more than a decade over the next two years.

The raise was suggested [in a report](#) from the [Missouri Citizens' Commission on Compensation for Elected Officials](#) in November. The General Assembly was required to reject the recommendations before Feb. 1 to strike them down, but only

the [House](#) took action on the piece, failing to pass [a resolution](#) disapproving the raise Thursday morning.

Even if the House had rejected the increase, the raise would have taken effect: The upper chamber had already adjourned for the week when the results were officially declared, leaving it no time to consider the resolution before its deadline.

“We were waiting on the House to send that measure over to us, so we weren’t in control of what happened,” Senate President Pro Tem [Dave Schatz](#) told reporters following adjournment. “At this point, there’s nothing we could do about it.”

Senate Majority Floor Leader Caleb Rowden said the raise could help support increased diversity in the General Assembly.

**SUBJECT: Reward Increase – 9 Year Old Dominic Young Homicide**

**KANSAS CITY, MO --- The Kansas City, Missouri Police Department and the Greater KC Crime Stoppers TIPS Hotline continue to seek information in the January 20, 2018 homicide of 9 year old Dominic Young Jr. at 71 Highway and Emanuel Cleaver II Blvd.**

**Dominic Young Jr. was apparently hit by a stray gunshot while occupying a vehicle**

---

driven by his father and died as a result of his injuries. Dominic, his father and brother were en route to Grandview at the time. The vehicle driven by Dominic's father was hit by gunshots from other vehicles apparently engaged in a gunfight according to statements.

KCPD found a possible crime scene near the intersection where the father said the shooting happened. When the father arrived home in Grandview, Dominic was not responsive. Grandview police initially responded to the father's home and found the boy in critical condition. He was later pronounced dead at a hospital.

A number of community leaders and organizations including State Representative Richard Brown, Mayor Pro Tem Kevin McManus, former City Councilmen Scott Taylor, Scott Wagner, John Sharp; the City of KCMO and Concord Fortress of Hope Church (Pastor Ron Lindsay) have come forward to increase the existing reward in the case up to \$30,000.00. Those leaders are available for comment in regard to the case.
